## Boarding agreement:

## Payment

This fee must be paid in full before the pet is allowed to board. Owners will be charged a day boarding fee if their dog is not picked up by noon on their final day.

## Responsibilities of River Run Pet Retreat

River Run Pet Retreat agrees to provide a safe, sanitary, and comfortable environment for \_\_\_\_\_ (Pet) while boarding. River Run Pet Retreat will also provide adequate food (provided by the owner) and water for \_\_\_\_\_ (pet), as well as exercise and socialization. River Run Pet Retreat agrees to keep [pet] in a secure area and will ensure [pet] is not exposed to any other animals that may cause harm.

## Responsibilities of [Pet Owner]

[Pet Owner] also agrees to provide River Run Pet Retreat with any necessary supplies, such as food, bedding, and toys, if necessary.

## Liability

River Run Pet Retreat is not responsible for any illnesses or injuries that may occur while [pet] is boarding. If the Pet becomes ill or if the Pet's behavior is endangering itself, humans, or other animals, the Kennel, in its sole discretion, may engage the services of a veterinarian. All attempts will be made to contact the Owner of the Pet first, however, in the event of an extreme emergency the well-being of the Pet comes first and appropriate action will be taken. Medication will be administered as necessary under the direction of a veterinarian. The undersigned Owner hereby gives the veterinarian and their assistants complete authority to treat Pet in whatever manner deemed necessary by the veterinarian on duty. The Owner will be responsible for all veterinary charges upon release of the Pet.

## Termination

Either \_\_\_\_\_ [Pet Owner] or River Run Pet Retreat can terminate this agreement at any time with written notice. In the case of termination, [Pet Owner] must pick up [pet] from River Run Pet Retreat within 8 hours.
